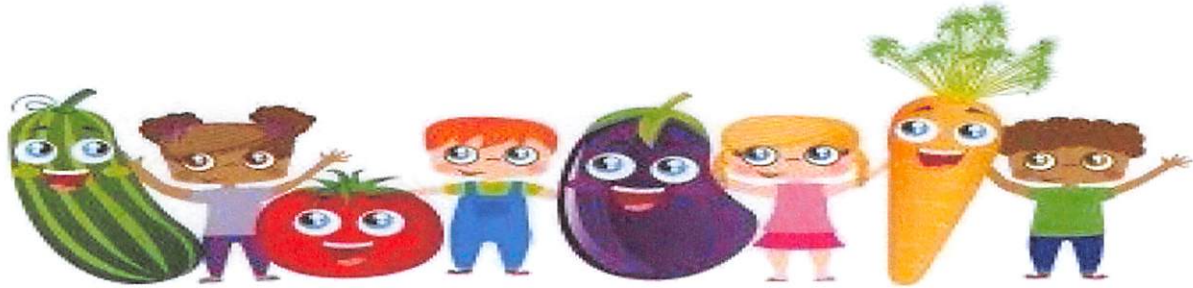


SUMMER MEALS!!!!
